#### TOWN OF CLINTON REGULAR BOARD MEETING

August 20, 2024

The regular meeting of the Town of Clinton was called to order by Chairman Peter Ramfjord at 6:00 PM with Supervisors Cal Warwas, Peter Ramfjord, Treasurer Elaine Santi, Fire Chief Jim Theodore, EMR Coordinator Kyle Tomczyk and Clerk Brian Mayry. Supervisor Robert Butler was absent. All in attendance recited the Pledge of Allegiance.

The minutes of the last regular meeting were distributed by the Clerk. Supervisor Warwas motioned to wave reading the minutes and accept the minutes as distributed, second by Chaiman Ramfjord. Motion carried unanimously.

The Treasurer's Report was provided and read by Treasurer Santi. Supervisor Warwas motioned to accept the financial report, second by Chaiman Ramfjord and unanimously carried.

Chairman Ramfjord motioned to pay the submitted bills and claim forms. The motion was second by Supervisor Warwas and prevailed unanimously.

Fire Chief Theodore stated the Department responded to five department alarms. Chief Theodore addressed the Township Board stating that there is another round of NFPA training has begun this fall. The new 2025 OSHA standards were touched on briefly. The air conditioner in the squad room has been replaced as the donated unit had quit. It is appearing that several firefighters may be stepping aside and Alex Donahue is requesting membership. Chief Theodore stated that he is looking at using Lexipol for the Departments SOPs.

EMR Coordinator Kyle Tomczyk stated that the EMRs received 8 alarms. The grant request for CO monitors was rejected. Responders will be attending monthly trainings that will count toward the biannual refresher. Corbin Anderson has requested to become a Clinton Emergency Responder. Chairman Ramfjord motioned to accept Corbin Anderson as an EMR. Supervisor Warwas second the motion and it prevailed unanimously.

Chairman Ramfjord stated the baseball fields are no longer being used by the local youth baseball program as the season has ended.

Chairman Ramfjord motioned that the meeting be adjourned until the next regular meeting on August 20, 2024, beginning at 6:00 PM. Supervisor Warwas second and the meeting adjourned at 6:35 PM.
